- \* Grant prior approval of previously contracted bills, during the 2022-2023 school year, prior to board meetings; and authorize the administration to pay normal bills during the months when board meetings have been canceled or rescheduled and do not allow for payments to be submitted for board approval. This allows the district to avoid late charges or take advantage of discounts for early payments.
- \* Approve the Agreement between Penn Highlands Dubois and the Union School District for the purpose of offering health care services, including the provision of the Sports First Aid Services, effective August 1, 2022.
- \* Revise the effective date of hire of Educational Aide, Tammy Craig, to reflect August 17, 2022. It was approved for August 19, 2022 at the May 12, 2022 board meeting.
- \* Approve a 5 year contract, effective July 1, 2022 through June 30, 2027 for Non-Association Members: Confidential Secretary and Data Administrator and Central Office Secretary.
- \* Approve a 5 year contract, effective July 1, 2022 through June 30, 2027 for the Food Service Director.
- \* Approve a 5 year contract, effective July 1, 2022 through June 30, 2027 for the Business Manager.
- \* Appoint Tom Minick as the Federal Programs Coordinator for the 2022-2023 school year and Appoint Brenda Greenawalt as Federal Programs Liaison for the 2022-2023 school year.
- \* Appoint John Kimmel as the Title IX Coordinator and Elena Steidinger as Section 504 Coordinator for the 2022-2023 school year.
