

UNION SCHOOL DISTRICT BOARD BRIEFS March 16, 2023

- * Approve the Treasurer's Report for the month ending February 28, 2023
- * Approve the Accounts Payable List for the month ending March 31, 2023.
- * Approve the Riverview IU6 2023-2024 General Operating Budget, in the amount of \$1,448,687.00 (Budgeted Expenditures), with Union School District's Projected share of \$ 4,306.00
- * Enter into an agreement with Snyder Brothers, Inc. to supply natural gas for 36 months at \$4.425 per DTH at Union High School and 36 months at \$4.16 per DTH at Sligo Elementary School.
- * Approve the contract for services between the Union School District and Empower Speech, LLC for speech and language services effective for the 2023-2024 school year.
